Journal of Palestine Studies Now Available Through Electronic Subscriptions

Washington, DC, June 23, 2014- Readers may now purchase **electronic subscriptions** to the *Journal of Palestine Studies*. For an annual fee of \$42, individual subscribers will receive online access to the *Journal of Palestine Studies* for a one-year period. Subscribers will have complete access to the journal's archive; beginning with the first issue published in 1971, and will receive access to each new issue published during the subscription period. Readers may purchase online-only subscriptions from the [UC Press website](http://ucpress.edu). All *Journal of Palestine Studies* issues can be accessed through the online content platform, JSTOR.

The *Journal of Palestine Studies* is the oldest and most respected English language journal devoted exclusively to Palestinian affairs and the Arab-Israeli conflict. The journal was first published in 1971 by the Institute for Palestine Studies under the Editor, the late Hisham Sharabi, Professor Emeritus of History and Umar al-Mukhtar Chair of Arab Culture at Georgetown University. **Rashid Khalidi**, Edward Said Professor of Modern Arab Studies at Columbia University currently serves as Editor of the Journal. *JPS* is published in partnership with the University of California Press.

The *Journal of Palestine Studies* offers in-depth articles, reports, interviews, and book reviews from leading political figures and experts. Regular features include the "Quarterly Update on Conflict and Diplomacy", a summary of political events affecting Palestinians and the future of the peace process; as well as "Selections from the Press," a collection of articles and news items from international press sources on topics relevant to Palestine. The journal also offers "Photos from the Quarter," a collection of photos from the occupied Palestinian territories.

The most recent issue of the *Journal of Palestine Studies*, Issue 170 features an article by Cecelia Baeza on the diversity and history of the Palestinian diaspora in Latin America, where the largest Palestinian population outside the Arab world resides. Issue 169 included an in-depth inside report by Nidal Bitari on the conditions in Yarmouk refugee camp in Damascus, Syria, and the effects that the Syrian War has had on its Palestinian inhabitants. The Journal's upcoming Issue 171 includes a 4-part commentary on the Kerry negotiations by leading experts on Palestine, examining international law, economics and land aspects of the negotiations.
